WARRANTY TERMS

- The Guarantor declares that the sold item is new, complete, unused, and free from any legal defects.
- 2. The Guarantor ensures the proper functioning of the subject of sale for a period of 24 months for individual customers and 12 months for entrepreneurs, starting from the date of the sales agreement.
- 3. The Guarantor undertakes to remove physical defects free of charge if they are revealed within the period specified in point 2 or to provide an item free from defects. The buyer is entitled to request a replacement of the item with an item free of defects if, during the warranty period, at least four repairs have been made and the item remains defective.
- 4. Warranty liability covers only defects arising from causes inherent in the subject of sale.
- 5. In the event of defects, the buyer shall deliver the subject of sale to an authorized service center.
- 6. The Guarantor undertakes to fulfill the obligations under this warranty within 14 days from the date of delivery of the sold item.
- 7. The risk of accidental loss or damage to the subject of sale, from the date it is delivered to the Guarantor until it is returned to the buyer, is borne by the Guarantor.
- 8. A condition for exercising warranty rights is the delivery of the subject of sale to an authorized service center along with the warranty card and proof of purchase.
- 9. The warranty does not cover:
 - Defects or damage caused by using the product not in compliance with the operating manual.



- b. Defects and damage resulting from improper storage, harmful atmospheric factors (among others: frost), modifications or repairs performed by unauthorized persons, incorrect installation, damage during transport, or fortuitous events.
- Products whose serial numbers have been removed or altered.
- d. Damage resulting from natural wear and tear of the product.
- 10. The warranty is valid within the territory of the Republic of Poland.
- 11. The warranty does not exclude, limit, or suspend the buyer's rights arising from the non-conformity of the subject of sale with the contract.
